6. Any other things with the permission of Chairperson.


While discussing the matter raised at that time, it was decided to submit the proposals for promotion under CAS to IGAC for screening.




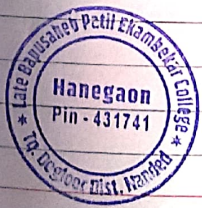


